Comfort Unite Back Supports have a weight limit of up to 300lbs (136kg) and must be properly sized for the individual. Comfort Unite Back Supports are available in the sizes 12 in. – 20 in. (30.5 cm – 51 cm) in Width (increments of 2 in. (5 cm)).

Comfort Embrace Back Supports are planar back support devices that are intended to provide trunk support and positioning for wheelchair users. The Comfort Embrace has a weight limit of up to 250lbs (113kg) and must be properly sized for the individual. The Comfort Embrace Back Supports are available in sizes 10 in. – 14 in. (25 cm – 35.5 cm) in Width (increments of 2 in. (5 cm)).

Comfort Relief Back Supports are back support devices that are intended to provide trunk support and positioning for wheelchair users. The back supports utilize an adjustable cable system to allow for individualized contouring of the back depth. Comfort Relief has a weight limit of 300lbs (136kg) and must be properly sized for the individual. The Comfort Relief Back Supports are available in the sizes 14 in. – 20 in. (35.5 cm – 51 cm) in Width (increments of 2 in. (5 cm)).
